- Effectiveness of EST

- Partner with other LEAs to learn about model & approach

- AOE specialists reflecting LEA NA results are identified
- AOE specialists reach out to discuss the need further and determine whether/not AOE support would be beneficial
- AOE supports are represented within LEA recovery planning, as applicable

TA PLANS FOR 173-RELATED PD: SPED RULE CHANGES

- Looking at other states' process & adapt/apply to the VT context
- Stakeholder input is a critical step in the SpEd team's process around tools, data types, guidance docs, exemplars & model sites identification, TA/training
- 7 Categories for the rule changes:
 - Adverse effect
 - SLD
 - Functional Skills
 - Goal writing
 - Parent Input
 - SpEd Definition (using the Federal Definition)
 - Recovery Efforts & Act 173

TA PLANS FOR 173-RELATED PD: EST

- EST Making Connections document
 - Help educators work through EST needs assessments and improvement conversations
- Possible peer resource and best practice sharing
- EST content woven into SpEd rule change implementation

TA PLANS FOR 173-RELATED PD: 173 FISCAL

AOE workgroup currently examining the following:

- What is the timeline for fiscal changes?
- How is the AOE/how should LEAs and schools be planning for the new funding model?
- When can we expect an update to the VT MOE calculator?
- What will Act 173 introduce re: new flexibility in funding infrastructure?
- How do LEAs account for MOE, state & local spending and IDEA-B funds in a way that maintains alignment with Federal definitions of special education while providing the flexibility intended under Act 173?
- What are the funding implications for LEAs concerning students attending independent schools? (Direct cost rates for services in independent schools)

KEY TAKEAWAYS FROM THE SUBCOMMITTEE MEETING

- Forecast PD support timeline to help districts w/planning PD
- Recommend a workflow for a district & acknowledge the enormity of the recovery planning, spending those funds & rules & funding changes timeline
- Resource library roll out & keep it rolling
- PR messaging around the changes that the AOE can play esp. with local boards
- Make connections between recovery work and Act 173 implementation
- What's **ONE THING** for the AOE to focus on right now, what would it be?
