	Discussed narrowing process
	Initial Thoughts:

- Cynthia Gardner-Morse: Concern about leaving decisions up to school boards and school districts; sees inconsistencies in MTSS guide (wants to see it pare downed to a two-pager); wants AOE to provide a list of science-based commercial programs (and those that are not science-based); suggests AOE consult a national reading expert to guide transition (Emily Leute says NIC work is focused on this)
- Susan Koch: Statewide assessment trainings, calibrating this model is
 effective because it ensures people have a clear understanding about an
 assessment and how to use it; think about the connection from PK to grade 2
 (Emily Leute says early literacy NIC working on this); benefit to having
 consortia (trainers for a whole section)
- Don Tinney: Remembers calibrating writing portfolios (labor-intensive but effective); concern about personnel shortages (keep this in mind as we consider recommendations); what is our role in looking at the MTSS system? (concern about lack of consistency from district to district)
- Bev Davis: Needs to read the state recommendations again, but remember <u>Alaska playbook</u> (very helpful); can't just put out a playbook and expect people to read and understand it on their own, but support it with PD (maybe remotely to address the personnel shortage)
- Ana Russo: Do LEAs know how to collect data that will be helpful for them?
 And interpret the data? Data collection and literacy training (Emily Leute
 says AOE has an RFP out for this); recommendation that AOE has capacity
 and appropriate expertise; have we explored different funding sources to
 help support LEAs?
- Michael Flanagan: online, asynchronous option could be really valuable
- Susan Gray: for MTSS to work well, it rests on the foundation of high-quality Tier 1 instruction (assessment and practice); Education Week articles about how popular reading programs are failing our students; can AOE create a slideshow to go with the VTmtss field guide that coaches can use to deliver PD to their schools?
- Gwen Carmolli: highly recommends culling resources and sharing out the really good ones
- Katie Campbell: Is it realistic to think that when we are done with making our recommendations that it's really going to be the AOE telling every school system what strategies/programs they can/cannot use?
