ITEM: Will the VSBPE act to adopt the updated endorsement revision timeline

AGENCY RECOMMENDED ACTION: The VSBPE act to adopt the updated endorsement revision timeline

BACKGROUND:

The VSBPE has determined that endorsements must be revised on a five-year cycle. This determination was made five years ago. Since that time, currently all endorsements are up to date based on the five-year cycle. In the past months there was a concern that Act 173 might impact the endorsement revision timeline. The Agency since made Rule change recommendations to the State Board of Education making it clear that the endorsement revision timeline will not be impacted.

RATIONALE FOR RECOMMENDATION: Proposed Rule changes relating to Act 173 did not impact the endorsement revision timeline.
