## Call to Order/Roll Call/Amendments to Agenda

The meeting was called to order at 11:05 a.m.

#### Approval of Prior Meeting Minutes from October 12, 2021 Meeting

Moved by Meaghan Morgan-Puglisi; seconded by Amy Wheeler-Sutton. Unanimously approved.

#### **Public Comment**

Jay Nichols shared responses from principals around the state about when they use suspension.

## **Working Session**

- Reports by Subcommittees and discussion of format of Initial Report
- Some discussion about who and how this committee is compensated Will request that Maureen Gaidys to resend information about that.
- Conversation about what constitutes a safety issue. It feels somewhat subjective to some members of the task force.
- There are some schools with very high exclusionary practice rates. Those need targeted intervention perhaps.



- Subcommittee 1 Report Amy Wheeler-Sutton
  - Have not heard back from Ohio about how their legislation was received
  - Discussed how mental health can be better in schools
  - Asked legal counsel to attend next meeting to help us understand the non-negotiables
  - How do we define Restorative Practices (RP) for the legislature? There is fear that if schools are not properly trained, RP can do harm. The subcommittee includes two definitions – one from John Kidde and one from the International Restorative Practices Organization

- Subcommittee 2 has not met since the last full task force meeting, so no significant update
  - Sandra reflected on crisis in staffing in the mental health field. We should be careful about recommending schools should tap into resources that are simply not there.
  - The AOE is depending on this task force in part to come to a common understanding about what results in serious behavior that warrants exclusionary discipline
- Subcommittee 3 Report by Heather Bouchey
  - Met a couple of times since last full meeting.
  - 2016 and 2017 data are available in reports that were specifically requested in laws.
    They took a year to put together.
  - Data shows an uptick in exclusionary discipline, but not enough information to see a pattern as to why or if the data is reliable
  - Hoping to have these reports available next week to the full committee
  - Discussion of different ways to collect data
  - Concern about our ability to identify instances of exclusionary discipline being used disproportionately in the case of students of color (due to our size as a state)

#### Action Steps for Subcommittees:

- We should produce an initial report that indicates what the subcommittees have been doing
- Amy will bring action items for subcommittees to complete as part of that initial report
- The task force recognizes and thanks Amy Wheeler-Sutton for her incredible work in keeping the report draft
