## Deb Giles September 2024:

**L/RSBs:** An August reminder was emailed to all L/RSBs which had yet to submit an Annual Report. Currently 57/61 Boards have submitted an Annual Report for 2023-2024. A September reminder will be emailed to the remaining Boards.

All L/RSB membership lists have been updated in the database and verified with Board Chairs who submitted an Annual Report. Changes to membership continues throughout the year and updates are continually made. Employment types L/RSBs will serve has also been updated in the database based on responses from the Annual Report. A list of employment types has been created to be posted on the website along with names and contact information of L/RSB Chairs. In August, the 2024-2025 list of L/RSB Chairs was sent to the VPA/VSA to be included in the Education Directory.

A list of Vermont Independent Special Education Schools is being verified by the AOE and the LSB Chairs. Once verified the list will be posted on the AOE website.

Grant allotments for each L/RSB are ready to be sent to Boards (which have completed all requirements) once the "kinks" in the GMS system are worked out. The allotment amounts were forwarded to Finance in August. The updated set of directions will accompany the individual allotments.

Our seasonal employee, Gary Moreau, has now left the AOE until the next renewal season and Deb has picked up the remaining 2024 renewals from Gary's queue. All renewals have been reviewed and the status of the remaining renewals is either awaiting payment or under review (on hold while waiting for a Criminal Record Check Report).

Deb continues to address L/RSB and SU/SD questions and concerns, along with questions from individual educators.
