Addison Central School District	Well-Rounded Education	Curriculum collaboration and embedded professional development related to our Title IV investment moved more slowly than we would have hoped in the second full year of pandemic teaching. Some progress was made in working with teachers on instruction and more progress was made in aligning scope and sequence work especially in the areas of literacy instruction and approaches to learning. This strengthened the foundation upon which we will continue to strengthen Tier I instruction across content areas.

Colchester School District	Well-Rounded Education	The planned curriculum work in social studies just happened - mapping out new curriculum and developing an implementation plan for 2023-2024. Progress has been made, but it is early in the planning and implementation phase.
Colchester School District	Safe and Healthy Schools	The CHS parent engagement has been limited during COVID, but survey results indicate interest and support for maintaining parent engagement for the high school. The district's equity professional development is yielding growth in understanding, curriculum changes, and practices, but the student data is not yet showing closes in achievement gaps.

So progress can be seen in some areas, in some grades, in some schools for some kids using both of those tools as well as our SWIS data.
Mount Abraham Unified School District	Safe and Healthy Schools	Investment #21 - training for leadership to support equitable practices in schools by "establishing learning environments and enhancing effective student learning skills that are essential for school readiness and academic success" yielding some measurable progress in terms of walkthrough data whereby there was evidence of some expected practices being utilized in some classrooms.
Mount Abraham Unified School District	Effective Use of Technology	Investment #19 - while our Mobile MakerSpace gained a lot of use and attention in our after school and summer programs and we continue to plan for ways to enhance the technology integration curriculum components, due to staffing capacity, COVID safety precautions and absences, the use of the MakerSpace hasn't yielded any measurable progress towards improved outcomes for students yet. Engagement, participation and creativity related to MILO with with our K-8 Expanded Learning population - particularly the middle schoolers - is inspiring, however and plans to work with our

We were not able to offer Developmental Designs due to low enrollment.

Although we believe this investment to have been substantial, we do not have adequate data that has measured the success/progress. It will be a goal of ours to address ways to gather measurable progress data for this investment.
Orleans Southwest Supervisory Union	Effective Use of Technology	Unfortunately this investment was not well utilized this year. We believe that the ability for staff to engage in professional development was limited at best. We continue to believe that this investment for the minimal cost is has is valuable and will promote the use of it going forward.
Rivendell Interstate School District	Well-Rounded Education	As a result of professional development that supports well rounded education our teachers have established a schedule for outdoor education and place based hands on learning opportunities. The measurable goals we need to review would be attendance and behavior data.
Rivendell Interstate School District	Safe and Healthy Schools	We were able to establish a connection with ALICE trainers who provided a training to all staff on September 2nd 2022. It is our goal to continue with further trainings throughout the year utilizing our title 4 funds.

One independent school could not find a mental health counselor to hire.

There are several highlights that students love! - Reading if for the Dogs! The consultant brings in support dogs for students to read to. Additionally, our cooking club was very active. They even participated in an "Iron Chef" competition. While they did not win, their Maple Alfredo was a huge success in our school community. Our other Well-Rounded investment was for VTVLC- an online course offering. We were unable to participate for several reasons (organization, availability), but hope to participate this year as we have a "Catamount" block that allows for more student choice and hope they attempt some language or art courses.
St Johnsbury School District	Safe and Healthy Schools	Our wellness room was created, and students accessed the room throughout the day, but primarily before school for students to practice their antianxiety techniques to prepare them for the school day. Our school continues to provide PD in the areas of Responsive Classroom, Developmental Design, and Trauma informed practices to ensure all students are taught by staff who are properly trained in these valuable practices. Also, we provided staff and parent/family trainings around the identification of anxiety and depression as well as wellness techniques. Lastly, one of our Independent Schools hired a SEL tutor to work with struggling students. This was well received and will continue over the

Though effective use of technology is still a goal within all investments, this year we were more explicitly focused on content areas 1&2.
Windham Southeast Supervisory Union	Safe and Healthy Schools	Two important investments involved supporting educators in working groups to improve engagement and school health and safety. Covid disruptions and educator stress prevented these groups from meeting on a sufficiently regular basis.
Windham Southeast Supervisory Union	Effective Use of Technology	Inability to hire qualified technology support specialists prevented successful implementation of two strategies in this area.
Winooski School District	Well-Rounded Education	We could not find anyone to hire to run our program for athletes. Disruptions from COVID and teacher exhaustion led to no progress on the emotional health of teacher's investment

Reporting Exemptions
