#### Why is the Home Language Survey Important?

- It is part of the identification process of multilingual/English language learners and immigrants. The identification process is required by federal law.
- Information gleaned from the Home Language Survey is used to meet state and federal reporting requirements.
- Accurate data ensures that each school/district will receive appropriate local and federal grant and other funding.




#### **Identification Process**

- We use the Home Language Survey to collect data identifying two populations that don't always overlap:
  - Multilingual/English language learners
  - Immigrant students
- Is it possible that a native-born Vermonter whose parents speak English fluently is a multilingual English language learner? Yes

## What is an immigrant student?

According to Title III, an immigrant child or youth refers to an individual who:

- ✓ is between the ages of 3 and 21 (up to their 22<sup>nd</sup> birthday);
- ✓ wasn't born in any State (including Puerto Rico);
- ✓ has not been attending school in any one or more states for more than 3 full academic years.
