

Local Foods Incentive 2022 Baseline Year Grant: Possible Award Amounts

Successful applicants for the Local Foods Incentive Baseline Year Grant will be awarded \$0.15 per lunch served during SY 20-21, as funding allows. For the current grant year (2022), \$500,000 has been appropriated to the Local Foods Incentive by the State Legislature. This means, if every eligible Supervisory Union (SU) and School District (SD) successfully applied for the grant this year, award amounts would exceed the appropriated funds and grant awards would need to be prorated.

The chart below shows the total number of lunches served by each eligible SU/SD in SY 20-21, as well as their maximum and minimum possible award amounts. Maximum possible award amounts were calculated by multiplying the number of lunches served by \$0.15. Minimum possible award amounts were calculated by multiplying the number of lunches served by \$0.0826, which would be the per lunch award amount if every SU successfully applied for the grant. Grant award amounts could fall anywhere within this range.
