Item A: Call to Order

Kolbe called the public hearing to order at 11:31 a.m. and welcomed members of the public and gave an overview of the Education Quality Standards (EQS) Committee's process. In April 2022, the State Board of Education received recommendations for changes to the EQS from the Act 1 Working Group. In May, 2022, the EQS Rule Update Committee began work on aligning the rules with the values of Act 1. In May 2023, the State Board approved a draft of these rules to be filed with the Interagency Committee on Administrative Rules (ICAR) and established three public hearings were scheduled. This is the second of three hearings. The next and final hearing is scheduled for Tuesday, October 3, 2023, 6:30 – 8:00 p.m. The deadline for public comment is October 15, 2023. She invited and encouraged written public comment be provided to the State Board of Education at SBE.PublicComment@vermont.gov.

Kolbe explained the technical and logistical details of the public hearing process and advised that comments should be respectful, will be limited to three minutes per person and should be related to the proposed changes to the 2000 Rule Series. Comments will be considered as potential revisions to the final rule.
