## **Unmet Need Story Sharing and Brainstorming:**

Discussion Items:

Are students who are home schooled who access and are enrolled in some school classes entitled to 504 Plan. They should be, does SEAP need to provide advisement.

Districts refusing to follow best practice in developing plans for children with disabilities.

Advocacy is extremely difficult for parents, often discouraging, and ultimately parents feel they cannot engage in broader advocacy while supporting the needs of their children.

Discuss lack of inclusion of parents of children with disabilities in hiring committees/panels.

There is a crisis level problem in proficiency performance of youth with disabilities and their nondisabled peers.

Use of Patterns of Strengths and weaknesses, which is significantly similar to the discrepancy model, for qualifying youth with SLD.

Additional Areas of Concern:

1. Child find/Evaluation
2. District agrees to sensory evaluations without completing

3. Providers not responding
4. What is specialized instruction/methodology
5. IEP goal bank - not utilizing individualized goals
6. Retaliation/bullying when families access dispute resolution

Lack of respect for and coordination with paras on teams

Local control makes it extremely difficult for parents to meaningfully advocate and expect consistency.

Parents are not treated as equal members.
