### Call to order, Review agenda, Updates from the Chair, Approve minutes:

### **Public Comment:**

### **AOE Transition Updates:**

Meg Porcella Interim Division Director for Student Support Services reported State Special Education Director applicants review and interviews at least 10 days out and Director of Division position need to be filled too. Susan requests that a couple members from the Panel be involved with interviews for State Director. Rachel stated there were questions sent to Secretary Bouchey on behalf of the Panel. Meg will ask again for the Panel to be involved. Remind Katie to send questions to Meg too. Secretary Agency on Education replacement is appointed by the Governor, the State Board of Education will conduct the search for the applicants and give their recommendation to the Governor after they do their interviews. There is a State Board of Education meeting in a couple of weeks, and I might know more then.

### Legislative Updates from Rachel Seelig:

Rachel Seelig provided background on legislative process. The week of Town Meeting Day is considered the beginning of what is called Crossover = if there are bills that are not about money, they have 1 week passed out to their committee and to the whole floor if it's a money bill they have 2 weeks. A couple bills of interest are: <u>S138</u>: School safety bill has 4 parts to it- drills for options-based drills, for active shooter situations, blocking buildings so that they are secure. But the section that's gotten some attention is about what are called Behavioral Threat Assessment Teams (BTAT).

<u>H409</u>: That is about the use of restraint and seclusion in schools, the House Ed is taking testimony looking for input to determine if changes are needed. Katie has and has shared with the Agency. Rachel testified and made recommendations to expanding the collection of Rule 4500 reports so that we have statewide data, prohibiting prone restraints, having some more oversight through perhaps a data collection, having a Training Advisory Committee, a complaint process and real way of getting restraints and seclusions monitored. I don't think they will adjourn and bring this back next January.

<u>H483</u> Provides changes to rules around the way that independent schools are funded. Legislature questions please contact me <u>Rachel</u>.

# Presentation on Behavior Threat Assessment Teams by Dan Stuart, Managing Attorney for Education and Employment, National Disability Rights Network:

Dan Stewart Managing Attorney at the National Disability Rights Network (NDRN), We are the Membership Organization for the Protection and Advocacy Systems in each of the States in the Federal Territories, along with the Native American Protection and Advocacy Organization. NDRN has been invited to participate in Threat Assessment Panels at the National level and in some other areas across the Nation. <u>NDRN Threat Assessment in Schools</u>.

Threat Assessments and Risk Assessments are not the same. Threat Assessments are narrow and focused on a small window of time. Threat Assessments are broader and can encompass more things (environmental threats, biohazards, pandemics). If you are researching articles, make sure to put in school based or behavior threat assessments.

### Part 1 of AOE presentation of SPP/APR from Ana Russo:

Ana presented on Indicator 5: Education Environments Children 5-21 <u>Indicator 5 Feedback Form</u> Helpful tool for calculations <u>School-Age Educational Environment Calculation Example</u>. Ana will be checking AOE Data Manager- when the students school days are shortened from those 6 1/2 hours to 3 hours. Where are those other 3.5 hours? Homebound placements, especially for students who are temporarily homebound while they're waiting for a separate school placement or who have been placed there as an interim alternative education setting. And then it goes long past 45 days. Three hours home bound and then 3 1/2 hours in the general education classroom. Shouldn't they be categorized as homebound? If that is? Because that would be less than 80% or at least part of their school day. Shortened school days ? Jacqui suggested that homebound instruction is a tonic that we need to put on our agenda. Dawn concurred
