Special Education Essentials: Building a Strong Foundation

During school year 2024-2025, the Agency of Education will be offering monthly professional development opportunities on special education essentials. The series is available to all educators with specific emphasis for pathway (d) participants, new teachers to the state, newly licensed teachers and graduates, special education endorsement candidates, general education teachers, high school special education teachers, Educational Support Teams (EST) members, evaluation team members, related service providers, and interventionists. VTmtss and Data Collection with Michele Hartje

October 22, 2024, from 2-3 p.m. and October 23, 2024, from 10:30-11:30 a.m.

All students are served within a system of support. This model is known as the Vermont Multi-tiered Systems of Support (VTmtss) Framework in Vermont schools. This session will provide an overview of the VTmtss Framework and its components. We will explore effective collaboration across general and special education teams as part of student support planning. This training will provide an overview of Functional Skills as it's listed in Basic Skill Areas in Rule 2392(g). Functional skills reflect a student's current abilities, skills, strengths, and weaknesses; academically, socially, and physically. Knowing this information about a student should shape the goals of their IEP by informing how their learning differences affect their ability to learn in the general education curriculum.

Parent and Family Engagement with Caitlin Chisholm and Nancy Hellen

March 25, 2025, from 1-2 p.m. and March 27, 2025, from 11 a.m.-12 p.m.

This training will focus on regulations and best practice related to Parent Participation in IEP Meeting and Parent Input. Participants will also review the Parent Involvement Survey and recent Vermont data related to the percentage of parents who report that the school facilitated parent involvement. Dispute Resolution with Cassie Santo
