- Vermont Automated Data Reporting (VADR) project.
 - Deliverables:
 - All K-12 Schools Participating in Automated Vertical Data Collection Process
 - Develop State-level Operational Data Store
 - All VTAOE Data Analysis Tool Date Loads Automated
 - Establish Enhanced Training Delivery System
 - All EdFacts Submission Files Capable of Being Automatically Generated
 - Develop Growth Model Reporting Tool



Three Components

A. Data Collection

- 1. Vertical Reporting (VR)
 - How do we get required data, in most efficient, systematic process, from schools to AOE?
 - Difficult given variety of local systems, capacity constraints, skills sets, vendors and products, etc.
 - This is where "local control" factors in
 - Required adopting new product/system (HMH), move to reporting at SU/SD level, significant levels of coordination and front-line training (for both schools and state)



Three Components (cont.)

B. Data Arrangement

- Pulling different types of collected data together so they can "talk to each other"
- Automatized verification of data
- Bringing data together from multiple files and sources of information (some in vertical reporting, some not)
- Matching data
 - Student level (permnumber)
 - School level
 - SD/SU level



Three Components (cont.)

C. Data Visualization

- How do we interpret and use the data?
- How do we organize it visually to understand it?
- What patterns do we detect?
- State Report Card/Snapshot
 - See handouts
