Today boys and girls ages 5-15 come from throughout the Northeast to Kurn Hattin to live in a safe, caring environment that supports their diverse needs. No child is denied admission for financial reasons; Kurn Hattin is a fully-charitable year-round home and school dedicated to helping children grow up to become happy, productive members of society.
