

# TA Tuesday: Goal Writing, January 31st, 2023

## **Purpose**

Hello Special Education Directors,

Every Tuesday, the AOE will be sending a technical assistance email to LEAs as a reminder and to provide any updates on available resources or professional development for a particular topic related to upcoming special education rule changes. Today's TA topic is goal writing.

The materials shared below are intended to support the rule changes related to goal writing. The changes for goal writing include using pertinent data to inform the development of appropriate goals and objectives. Assessing goal progress shall also include the specific data for measurement. It is the expectation that individual student data will inform the development of writing goals and objectives and will be used to monitor progress on goals.

## **Goal Writing**

The rule changes related to the Content of the IEP (34 C.F.R. § 300.320) are below, with the omissions and additions bolded, effective July 1, 2022.

- "(b) Measurable annual goals related to the child's present levels of academic and functional performance which shall:
- (1) Use pertinent data to inform the development of appropriate goals and objectives.
- (2) Be written as measurable short-term objectives or benchmarks with projected dates for accomplishment, including a description of the evaluation procedures to be used to measure the child's progress towards meeting the short-term objectives or benchmarks; and the specific data that will be used to assess goals progress."
